## **Petland in Ohio: Where Do They Get Their Puppies?**

Petland claims that they only buy from breeders with “the highest standards,” but the Humane Society of the United States (HSUS) has found that they continue to buy from **known puppy mills** and **out-of-state brokers** that deal with puppy mills. The Ohio Petlands bought puppies from at least five major brokers which the United States Department of Agriculture (USDA) has cited for **multiple violations**.

A **broker** is a “middleman” animal dealer that buys puppies from many different kennels and puppy mills for resale to pet stores.
